



Please, find below a list of forbidden items by the Brazilian Customs:

ITEM ITEM	PROIBIDO FORBIDDEN	RESTRIÇÃO RESTRICTION
Fire arms, ammunition, sword, knives.	-	Shipper must provide import permit from the representative of the Brazilian army at origin. Failure in providing this document will cause confiscation by customs and shipper will respond in court for this act.
Cars	Yes	Only pre-exported cars from Brazil as temporary export
Airplanes	Yes	-
Alcoholic and non-alcoholic beverages	-	Subject to 100% of duties and taxes. If shipper declares as "rest of cellar" it will be up to the Customs Official to charge duties or not. These duties must be paid by the shipper. Failure to declare may cause confiscation and fines.
Electric Bicycles	Yes	-
gas grills or propane tanks	Yes	-
Shipping documentation and related fees	Yes	Please do not put into your move your personal documents. They will be used for customs clearance in Brazil. Bring them with you, in your hand luggage.
New items, electric or not, in quantity superior to 1 per category (you cannot bring to Brazil more than one electric / electronic item with the same brand, type, size). You can bring more than one electric / electronic item if they have different brand, type and size.	-	Must be declared as "new" and will be subject to 100% of duties and taxes. If these items were declared as used and during the inspection are found and consider new, shipper will pay 100% of duties and taxes plus 50 % fine.
Cleaning, material and related goods	-	Subject to 100% of duties and taxes, must be declared as consumable goods. If not declared, may be confiscated and/or fined. These charges will be billed to the shipper because they are not considered Unaccompanied Baggage.

<p><i>Power tools (larger than 25 pounds each)</i></p>	Yes	Normal small tools are allowed (hammer, screw driver, etc)
