**PROHIBITED ITEMS FROM IMPORTATION**

I hereby declare to the best of my knowledge the following, which I understand to be of the interest to the China Customs Authorities. All items being imported into China have been in my possession for my personal use and don't include any articles prohibited with the law of the People's Republic of China:

- 1) Firearms, Ammunition, Weapons & Explosives ( Included Strapped-down Gun, dagger)
- 2) Bow
- 3) TV Satellite Dish
- 4) Telecommunication equipments, including cordless phones
- 5) Over size office items, such as large photocopier machine, printer, which are not consider for personal or family usage
- 6) Animals and Animal Products, such as unprocessed food, fresh meat, dairy products
- 7) Plants and Plant Products, such as live plants, fresh vegetables, soil and pesticide
- 8) Poisons or illegal drugs, Neuropathic Medicine, daily medicine and Vitamin
- 9) Printed/recorded material deemed detrimental to the political, economic, cultural, or moral atmosphere in China (including all pornographic materials)
- 10) Maps (where the Chinese border is not in accordance with Chinese law)
- 11) All kinds of equipment /tool associated with gambling (such as poker cards, chips, jackpot machine etc)
- 12) Endangered and rare animals and their products such as ivory
- 13) Counterfeit currencies
- 14) Unhealthy animals
- 15) Motorcycles, Mowing machine, Model & Equipment with large engine
- 16) Grand Piano
- 17) Diving Equipment
- 18) Pet Food
- 19) Any other items that are determined by the local Customs Bureau to be of non-personal or non-family usage. These items may be seized if found in the shipment.

I have read the above instruction and confirm that I don't have the above prohibited items in my shipment to China. I take full responsibility for any fine, composition or delay caused by an incorrect declaration.
